Coronavirus (COVID-19) - Update 2

Further advice for taxi and private hire licensees

This Notice supplements <u>TPH Notice 03-20</u> (published 19 March 2020). It is being issued following the further steps announced by the Government, on 23 March 2020, in its continued efforts to delay the spread of Coronavirus (COVID-19).

Licensing service

Our focus remains on supporting critical taxi and private hire licensing functions. This will primarily be licence renewals and acting on safety-critical intelligence. To ensure the safety and welfare of our staff and to ensure all available staff are focussing on these critical licensing tasks, we have taken a decision to close our phone lines and will operate an email-based customer service until further notice.

Please only use these email addresses if your enquiry is essential as we are operating with a reduced number of staff e.g. if your licence is due to expire imminently.

Knowledge of London and Topographical testing

As a sensible precaution, in response to the Government statement, and to protect the welfare of our staff and applicants, we will not be undertaking Knowledge of London or Topographical testing until further notice. **Please do not travel to any of our assessment centres which are now closed**. Applicants who have a booking will be contacted by us in the coming days.

Processing new taxi or private hire driver applications

Due to a reduced number of staff and the temporary closure of our taxi and private hire assessment centres, we are currently unable to process new taxi or private hire driver applications unless an assessment has already been completed and passed.

NSL vehicle testing inspections

In response to the latest Government statement, we have taken a decision to temporarily close the six NSL Vehicle Inspection Sites with immediate effect while we consider what services we are able to offer to support the ongoing licensing of vehicles. We will provide an update on vehicle licensing in a subsequent TPH Notice.

Health, wellbeing and financial circumstances

The health and wellbeing of licensees is important to us and we are conscious of the challenging and unsettling nature of the current situation in light of the Coronavirus pandemic.

We have created a <u>licensee health and wellbeing webpage</u> to raise awareness of some of the services, guidance and support that is available covering physical and mental health and overall wellbeing.

This includes the Money Advice Trust, a national charity helping people across the UK to tackle their debts and manage their money with confidence. It offers free, independent and confidential advice on personal debt and Business Debtline, the UK's only free dedicated debt advice service for people who are self-employed and other small business owners.

Key worker status

We, alongside taxi and private hire trade representatives, are seeking urgent clarification from Government as to whether taxi and private hire drivers are defined as key workers. As soon as more information is known we will issue a further Notice.

Regular conference calls are now scheduled with trade representatives and we will use a range of methods to disseminate important information to you.
