1 Summary

- 1.1 The purpose of this paper is to update the Committee on the Connect strategy proposed in October 2017.
- 1.2 This strategy provides new arrangements, for a limited period, that deliver continuity of telecommunication services following the expiry of the Connect Private Finance Initiative Contract between London Underground and Citylink Telecommunications Limited.
- 1.3 A paper is included on Part 2 of the agenda which contains exempt supplementary information.
