

## Northern line extension

Changes to proposals to extend the Northern line



In April 2013, Transport for London (TfL) submitted an application for a Transport and Works Act Order (TWAO) to extend the Northern line to Nine Elms and Battersea. Our submission marked the beginning of

a statutory consultation period (until 18 June 2013) on the proposals and comments for or against the scheme could be submitted to the Secretary of State for Transport.

The proposals include:

- New stations at Nine Elms, near the existing Sainsbury's supermarket, and at the former Battersea Power Station
- Permanent shafts at Kennington Green and Kennington Park to allow air in and out of the underground tunnels, help cool the Tube and enable emergency access to and from the tunnels if necessary
- Temporary shafts at Radcot Street and Harmsworth Street, or as an alternative, underground 'gallery tunnels', in preparation for the new tunnels to be built.

Following feedback from consultation, further engagement with stakeholders and the conclusion of engineering feasibility work, changes have been made to the scheme including:

### 1. Kennington Park – removal of proposed community building

Consultation, in autumn 2012, on the design of the head house at the old lodge site at Kennington Park, demonstrated support for the inclusion of a community space for activities relating to the park.

Further to discussions with the London Borough of Lambeth (LBL), we have agreed to remove the proposed community building from the scheme on the basis that LBL would prefer to support existing community facilities in the surrounding area. Our proposals for landscaping around the head house have been amended and the planting of trees and plants in the area previously taken up by the community building would open up this corner of the park.

The bee keeping and other community activities carried out at the old lodge are proposed to be relocated by LBL to another area in the park. This would provide facilities for bee keeping on a more permanent basis irrespective of permission being granted to build the Northern line extension (NLE) and in advance of the start of construction.

### 2. Removal of temporary shafts at Harmsworth Street and Radcot Street

Our TWAO application included two potential construction methods (via underground 'gallery' tunnels or temporary surface shafts at Harmsworth Street and Radcot Street) to connect the old tunnels to the new NLE tunnels and to stabilise the ground. The impacts of both these options were assessed in the Environmental Statement (ES).

Following further feasibility work the temporary shafts have been removed from the scheme on the basis they are no longer required. This means that no above ground works will be undertaken at either Harmsworth Street or Radcot Street and construction works will be progressed via underground gallery tunnels from the proposed worksites at Kennington Park and Kennington Green instead.

## Environmental Statement Addendum

As a result of these changes and additional information we have prepared in response to objections to the NLE proposals, we have published an Environmental Statement Addendum (ESA). The ESA sets out changes or additions to our ES and provides additional information relating to ground settlement, a preliminary navigation risk assessment, traffic and transport and other issues.

The ESA was submitted to the Secretary of State for Transport on 27 August and this new information is now the subject of a six week consultation process.

In order for the Department for Transport to consider your comments, your response must include your name and postal address and clearly state your comments on the ESA.

## Why do we need the NLE?

The extension is essential to enable the regeneration of the Vauxhall Nine Elms and Battersea area, including the creation of 16,000 new homes and 25,000 new jobs. It will also put thousands more people within easy reach of the Tube network, reduce travel times to central London, relieve pressure on Vauxhall station and provide relief to the existing Northern line south of Kennington.

## Our next steps

ESA consultation period closes (8 October 2013)

- Public Inquiry (autumn 2013)
- Decision on TWAO application (autumn 2014)

Proposed start of construction (from spring 2015)

Subject to permission to build and operate the extension, the new stations at Nine Elms and Battersea could be open by 2020
