Briefing Note: The Trial of 20mph Speed Limits on the Transport for London Road Network (TLRN)

1 Purpose

1.1 The purpose of this briefing note is to provide an update to the Transport for London (TfL) Safety, Accessibility and Sustainability Panel (SASP) on the trial of 20mph speed limits on the Transport for London Road Network (TLRN), following a request at the meeting of the Panel on 5 March 2015.

2 Background

- 2.1 Using the Roads Task Force (RTF) report as a framework, TfL is developing an approach for identifying the potential for wider use of 20mph limits on the TLRN across London.
- 2.2 When considering whether a 20 mph limit would be suitable for the TRLN, TfL's key aims are to reduce casualties, increase active travel and to enhance places, whilst at the same time seeking to minimise the impacts on traffic and buses.
- 2.3 Building on already ongoing pilots of 20mph at Waterloo IMAX roundabout and on two key routes through the City of London, TfL is introducing 20mph speed limits as trials at eight new locations (see figure below). These routes, across seven boroughs will help to understand the most effective means of implementation and compliance, particularly on busier roads where both place and movement functions are important. The sites were identified through assessment of a range of data such as level of pedestrian and cycle activity, collision history, network characteristics and borough aspirations. Detailed investigation, design and modelling will be undertaken over the coming months to develop the proposal. The results of these trials will be used to inform the suitability of reduced speeds limits on the various road types across, both inner and outer, London.

3 Trial Locations

3.1 The first of these new pilot locations is Commercial Street in Tower Hamlets, and was introduced in April 2015 when all borough roads in Tower Hamlets were made 20mph. TfL will now work closely with the relevant boroughs to investigate the potential for 20mph speed limit pilots at the following locations:

- Upper Street and Holloway Rd (between Pentonville Rd and Seven Sisters Rd);
- (b) Westminster Bridge, Stamford Street and Southwark St;
- (c) Brixton Town Centre (between St Matthews Rd and Stockwell Park Walk);
- (d) Clapham High Street (between Clapham Park Rd and Bedford Rd);
- (e) Earls Court Rd and Redcliffe Gardens (between A4 Cromwell Rd and Fulham Rd);
- (f) Kings Cross Rd and Farringdon Rd (between Pentonville Rd and Charterhouse Rd, linking up with the previous 20mph trial along Farringdon St and Blackfriars Bridge); and
- (g) Camden Street (between Camden Rd and Crowndale Rd).

4 Next Steps

4.1 The speed limits will be introduced under an 18 month experimental order and will be subject to detailed monitoring. Traffic speeds, casualty data, safety perceptions and the number of cycling and walking trips will be monitored along with the effects on bus and traffic journey times, to assess whether to make the reduced speed limits permanent. Results from the City of London 20mph routes will be announced later this year.
