SCHEDULE 12

ENVIRONMENTAL REQUIREMENTS

1. Compliance with the Code of Construction Practice

- 1.1 Project Co shall at all times comply with the Code of Construction Practice in accordance with clause 5.10 (*Code of Construction Practice*).
- 1.2 Without prejudice to any other requirements of this Agreement, Project Co acknowledges and agrees that the Code of Construction Practice details the minimum environmental control measures to be implemented by Project Co during the period from the Effective Date to the Permit to Use Date to minimise any harmful environmental impact of the Works.

2. Compliance with the landscaping plan

2.1 When carrying out the Works, Project Co shall at all times comply with the landscaping scheme (produced in accordance with the landscaping plan) in accordance with the Transferred DCO Functions.

3. Compliance with the flood risk assessment

3.1 Project Co shall at all times comply with the flood risk assessment in accordance with the Transferred DCO Functions.

4. Compliance with operational noise mitigation measures

4.1 When carrying out the Works, Project Co shall at all times comply with the operational noise mitigation measures in accordance with the Transferred DCO Functions.

5. Compliance with the Biodiversity action plan and mitigation strategy

5.1 Project Co shall at all times comply with the biodiversity action plan and mitigation strategy in accordance with the Transferred DCO Functions.

6. Compliance with the requirements for contaminated land

6.1 Project Co shall at all times comply with the contaminated land requirements in accordance with the Transferred DCO Functions.

7. Compliance with conditions of Deemed Marine Licence

7.1 Project Co shall at all times comply with the Deemed Marine Licence (as defined in the DCO) in accordance with the Transferred DCO Functions.

8. Compliance with protective provisions

8.1 Project Co shall at all times comply with the relevant protective provisions for the protection of the Port of London Authority and the Environment Agency in accordance with the Transferred DCO Functions.

9. Vehicle emissions

- 9.1 Project Co shall ensure that all vehicles used by Project Co or any Project Co Related Party in connection with the Project comply with the following CO₂ limits:
 - 9.1.1 cars: maximum certified CO₂ emissions of 105 g/km;
 - 9.1.2 vans with a kerb weight equal to or less than 1205 kg: maximum certified CO_2 emissions of 115 g/km CO_2 ;
 - 9.1.3 vans with a kerb weight greater than 1205 kg but equal to or less than 1660 kg: maximum certified CO₂ emissions of 155 g/km CO₂; and
 - 9.1.4 vans with a kerb weight greater than 1660 kg: maximum certified CO_2 emissions of 215 g/km CO_2 .

10. CEEQUAL

10.1 Project Co shall achieve a CEEQUAL Whole Team Award to at least Very Good Award, aspiring to the achievement of 'Excellent' where the project scope allows.
