Supplier Perception Survey

Thank you to our suppliers who completed this year's TfL Voice of the Supplier survey. More than 70 per cent of suppliers across TfL who were invited to take part responded.

Initial results show that there has been an improvement in satisfaction levels.

We presented some initial high level results at our Surface Transport supplier event in October and will complete some more detailed analysis so that we can share more with you over the next couple of months.

Road Safety and Other Information

Improving road safety in our Capital

As part of our commitment to improving the safety of all road users in London we are determined to work with our suppliers to

- maintenance Trueform (to August 2020) for £33m
- Shelters painting Dabs (to August 2015) for £2.4m
- Stops supply, installation and reactive maintenance - Trueform (to August 2020) for £13m
- Publicity posting Mitie (to August 2020) for £5m
- Cleaning and graffiti removal Mitie (August 2020) for 2.4m
- Stops and shelters electrical maintenance - Skanska (to August 2020) for £4.4m

- Tunnels outstation maintenance -Cubic (to July 2021) for £47m
- Hydrogen fuel cell buses Van Hool (to March 2020) for £1.3m

We continue to take steps to ensure all of our suppliers and their sub-contractors who deliver to, or serve any of our work sites (including our head offices and depots) comply with safety requirements known as 'Work Related Road Risk' requirements (WRRR). This includes having safety equipment on vehicles, ensuring drivers undertake training and achieving a minimum of Bronze accreditation in our Fleet Operator Recognition Scheme (FORS). Failure to comply could result in a vehicle being refused access to a site and the delivery being recorded as a 'failed delivery'. Please cascade this message through your supply chain.

Surface Supplier Event

We held a supplier event on 2 October which included presentations by TfL Surface Transport senior directors who set out our 10 principal outcomes, the challenges of the Comprehensive Spending Review, our new Commercial strategy, and early results from the Supplier Perception survey.

Who we are and what we do

Our 'Who we are and what we do' document has recently been updated. The document details how Commercial is responsible for implementing and managing contractual requirements with our suppliers. This begins with setting a Commercial Strategy and proceeding through to contract management via UK and EU compliant polices and procedures.
